The United Nations Flagship Report on Disability Development (UN Dec: 2018. A/73/220) advocated for the training of Healthcare Professionals on disability inclusion to attain the highest achievable standard of health for persons with disabilities. Even as we find that disability rights are just beginning to get attention in the competency based curriculum of National Medical Commission (NMC) after much judicial advocacy, disability competencies have become a part of formal content in medical colleges. The impetus to creating greater awareness among all professionals regarding the attributes essential to providing quality care to persons with disabilities comes also from a new human rights model with disability proposed by the UNCRPD.

The first of the webinar series, on Nov 13, 2021, has the objective of providing an introduction to the competencies of abilities build around the core values of human rights inclusive of disability rights that should be built into the pedagogical skills of medical teachers and allied health professionals who mentor healthcare workers, caregivers and persons with disabilities to play a pivotal role in Inclusive Development.
